FOR PARENTS / CARERS OF CLOSE CONTACTS OF COVID-19 at St Katherine's School

Advice for Child to Self-Isolate for 10 Days

Dear Parent/Carer

Further to the multiple positive LFD test and subsequent positive PCR tests reported within the school community, we are writing to confirm how this impacts on students within each year group. Thank you for your patience as we have carried out this complex tracing with multiple cases. Please read the information below and should you have any questions please contact the school.

This letter confirms you have been identified as a close contact.

Learning@Home

Lessons will continue to be independent lessons all delivered through Google Classroom. This will be a blended approach with live content where possible. We will endeavour to do all we can to help students keep engaged in their learning during this time.

We have followed the national guidance and, following a risk assessment with Public Health England (PHE) advisers, have identified that your child has been in close contact with the individual who has had a positive test result for coronavirus (COVID-19). **In line with the national guidance, your child must stay at home and self-isolate until Thursday 15 July (10 days after contact).**

If your child is well at the end of the 10 day period of self-isolation, they can return to their usual activities from Friday 16 July.

Other members of your household can continue normal activities, provided your child does not develop symptoms within the 10 day self-isolation period.

What to do if your child develops symptoms of coronavirus (COVID 19)

Having been identified as a close contact, if your child then develops symptoms of coronavirus (COVID-19), they should remain at home for at least 10 days from the date when their symptoms appeared. Symptoms of coronavirus (COVID-19) are a new, continuous cough, or a high temperature, or a loss of, or change in, their normal sense of taste or smell (anosmia). Anyone with symptoms will be eligible for a PCR test - this is the type of test that

is normally available and can be arranged via <https://www.nhs.uk/ask-for-a-coronavirus-test> or by calling 119.

People who do not have symptoms or have not tested positive using a Lateral Flow Device should not request a PCR test unless this has been specifically requested by Public Health England or the local authority. All other household members who remain well must stay at home and not leave the house for 10 days. This includes anyone in your 'Support Bubble'.

The household isolation period includes the day the first person in your household's symptoms started (or the day their test was taken if they did not have symptoms) and the next 10 full days. This means that if, for example, your 10 day isolation period starts on the 15th of the month, your isolation period ends at 23:59 hrs on the 25th and you can return to your normal routine.

Household members should not go to work, school or public areas, and exercise should be taken within the home. If you require help with buying groceries, other shopping or picking up medication, or walking a dog, you should ask friends or family. Alternatively, you can order your shopping online and medication by phone or online.

Household members staying at home for 10 days will greatly reduce the overall amount of infection the household could pass on to others in the community.

If you are able, move any vulnerable individuals (such as the elderly and those with underlying health conditions) out of your home, to stay with friends or family for the duration of the home isolation period. If that is not possible, anyone with symptoms should try and stay as far away as possible from vulnerable members of your household.
